Page 4:

Page 10:

Page 11-12:

Gad was one of those tribes that largely fled during the Babylonian invasion leaving behind only a small number of them compared to the numbers that left before the Babylonians came upon them. When the Romans invaded what remained of Gad completely left the Middle-East to far out lands that the Romans did not control. Those families of Gad meant with other families of Gad who already established themselves in these new lands across the ocean waters. The investigation reveals that many houses of the Tribe of Gad became Native American tribes of North America later on.

Page 12:

Asher was another tribe that fled during the Babylonian invasion, and the rest of them left the Middle-East during the Roman invasion. They too also went to lands across the ocean believed to be the fathers of many South American native tribes like the Incas.

Page 12:

The Tribe of Naphtali also scattered during the Babylonian invasion, and the rest of them left the Middle-East during the Roman invasion. It is believed that they also contributed to the founding of other South American native tribes.

Page 13:

When Dan left Israel it became more common for the tribe of Joseph to start seeing themselves as the Tribe of Ephraim, and the Tribe of Manasseh respectively as Manasseh replaced Dan to account for 12 tribes

Page 14:

During the first invasion by the Babylonians many members of the Tribe of Joseph fled towards Sidon, and from there they boarded ships that took them around Africa, and down into the islands called the Caribbean. The two main islands they established a colony on was the island called Puerto Rico where Ephraim settled, and no Ephraim did not call the island Puerto Rico but the Spanish did. The second island they settled was called by the Spanish as Cuba, and there the people of Manasseh settled. From the Caribbean these tribes eventually adopted new names, and even other religious practices that was not from God.

Page 14:

After they settled these islands the Tribe of Joseph eventually came to call themselves to the other tribes they became friendly with as Tainos which was a word that meant in Hebrews in that part of the world. The Tribe of Joseph had a reputation for friendliest, and achieving non-hostile terms, and agreements with other native tribes. The islands that the Tribe of Joseph settled were not originally called Puerto Rico or Cuba but they were both called Borinquen. The word Borinquen is a Hebrew word that means, 'Land of the Brave Lords.' The Tribe of Joseph would also expand into other parts like northern Columbia, lower Florida, lower eastern Texas, eastern Mexico, and upon several scattered islands within the Caribbean. During the Roman invasion the remaining people of Joseph escaped the Middle-East, and fled into India. There they made their way to several islands off the coasts of Asian countries, and in the midst of Pacific Islands.

Page 15:

Eventually during the two kingdom years many members of the tribe of Benjamin left Israel, and ventured into the lands known as India where they formed a government with other tribes they were related to who were descendants of Shem. That government became what we know as India. During the Roman invasion many from the Tribe of Benjamin were still living in the Middle-East as they avoided persecution by becoming Roman citizens or they applied trade with the Romans. Many of the Greek-Jews who were Hebrews who lived like Gentiles came from the tribe of Benjamin in fact the Apostle Paul came from that culture of Alexandrian Jews.

Page 17:

It was Babylonians, and then the Romans who finished off Egypt. That was the same case for the tribes of Israel as well.

Page 18:

The tribes of Judah, Levi, and Simeon had fled into Africa after the Romans destroyed the temple in Jerusalem. These three tribes settled into central, western, and southern Africa among previous descendants of Solomon. For a time they built several kingdoms there, and they would eventually become Muslims when Mohammad invaded Egypt, and started to spread Islam throughout Africa. The ones that did not become Muslim were mostly of the Tribe of Levi. The Levi tribe adopted a magical religion called Obi also known as voodoo in America. It should be noted that none of these tribes were calling themselves by their original name any longer but they were considered to be people of new African nations. When the European invaders came they were being funded by the banking families in Europe to engage in human slavery so thereby they could form batch assignment workers to send them to lands they planned on invading in the new world. The European imperial alliance at the time used mainly the Dutch trading company to engage this awful practice. The Dutch traders made deals with African kings, and warlords wherein the deal was that the Dutch would pay these African royals in gold, horses, and guns if in return these African royals surrendered certain people to them to use them as slaves. These cities held the information of the written history of their tribes by the scholars of their tribes who were killed by the European soldiers. The Europeans before they engaged the battle used various chemicals by dropping these substances into the water sources, and land ^ animal sources of the tribes. The sickness produced by the chemicals were sicknesses the tribal people were not used to. These sicknesses were called smallpox, typhoid, etc. and these plagues killed millions of the natives in time. When the plagues first broke out is when Europeans stopped chatting with the tribal leaders, and started to aggressively make total war on them. The tribes were set-up, and ambushed, and in truth they never saw it fully coming in till it already broke out on them like a wrath shot from an invisible cannon. The slaughter, and the destruction was so intense, and the blood was so thick that it astonished even the European soldiers when they reflected on what they just did. Columbus gave an example of that in his diary when he showed remorse for the attack on the Tainos on the island known as Puerto Rico today. Even Catholic priests who were few by the numbers, were running back to Europe telling the Pope that he needed to speak with the monarchs, and the bankers about the slaughter of the native people. These priests' complaints were mostly ignored even by their own Pope.

Page 22:

Let us look at the Book of Jeremiah chapter 9 verses 14-15, 'But have walked after the imagination of their own hear, and after Baalim which their fathers taught them. Therefore thus saith the Lord of hosts, the God of Israel. Behold I will feed them even this people with wormwood, and give them water of gall to drink.' IN this chapter in Jeremiah the phrase wormwood is not being used to describe a planet but being used to describe chemical poisoning that was inspired by demonic agency. It was believed in the ancient past that the gods came from that planet, and they had a habit of poisoning whatever they touched on the ground. So if they touched a water source then that source of water was not good for drinking. It was also believed that such demons taught such methods of poisoning to their elites followers. God is revealing in these verses that the native Israelite tribes became a people fueled only by their own imaginations regarding spiritual matters. Such a practice to only lean towards on'e imagination is like a person telling you that they do not need to read the Bible because they believe in, 'following their own heart.'

Page 23:

Many of the Israelites during the Babylonian invasion as you know were not able to flee them. Most of them by the numbers were captured by the Babylonians while only a few of them by the numbers fled. However when the Babylonians had them in their lands the Babylonians relocated a large number of them. What they did was put them on ships, and sent them out in different directions. Therefore

Zebulon's people were not the only ones sending out ships of Israelites to new lands. After they did it the Babylonians began to do it as well. The reason has always been mysterious but the oral tradition was that the Babylonian elites noticed the high birth rate the Israelites seemed to have.

Page 23:

What people do not seem to understand is that the Babylonians were also a people descended from Shem as the Israelites were. The tribes of Shem during the early years just after the flood had branched out into eastern Asia, and eventually they did in fact make their way to North American lands. The first tribes that came there are represented in the Eskimo tribes, and other ancient tribes of those lands. Those tribes were descended from Shem as the Babylonians were also part of Shem's family line. The Babylonians were aware of the far away tribes, and had limited contact with them. It was strongly believed that the Babylonians began shipping Israelites to these lands as they came to first live under the nations of their cousins so to speak.

Page 24-25:

The people of Japheth are the original settlers of the lands called Europe today. The prophecy regarding Canaan happened when Alexander the Great representing that timeframe's European Empire that was led by the northern Greeks at the time wherein their empire represented the people of Japheth. Alexander was the one who finally destroyed all the power the people of Canaan had left which existed in Tyre & Sidon at the time. Therefore Canaan became the slaves of the Greeks during that timeframe. Alexander manages to invade the Middle-East, and India along with Northern Africa namely Egypt. Alexander did rule the most powerful empire in the world but he also knew that he did not completely enlarge Japheth on a world-wide level. The 'tents of Shem' was to show that Shem's people would enlarge themselves around the world before Japheth's people does so. When Japheth's people finally enlarges themselves they will come to live under the 'tents' of Shem which is to say among the lands of Shem's people that are found...around the world! The time when Japheth officially became a people found around the world is when the European invasion took place on the new world. After that the prophecy of Japheth was fulfilled. But how it was fulfilled is very sad indeed.

Page 31:

At the time when Joseph confronts his brothers is when Joseph was now a high ranking prince in Egypt.

Page 33:

The next tribe we will examine is called The Tribe of Levi. The general meaning of the name Levi is, 'wreathed.' The overall meaning of the name is more like to signify a spiritual position which would relate to a priest. Levi as we studied was similar to Simeon in personality but his temper, and character was more reserved than Simeon's character. This means Levi was more cunning as Simeon was more in-your-face.

Page 34:

The Tribe of Levi like all Tribes of Israel would settle in Egypt in the land of Goshen. Overtime the Pharaoh Shepherd family line which was the family that remembered Joseph, and honored the Israelites were overthrown by another family line that sought to get back the throne of Egypt from the Shepherd Clan. When this new Pharaoh rose to power he remembered not Joseph, and he engaged in a series of policies that was followed up by his sons to put the Israelites into slavery which they eventually did. The land of Goshen was now a quarter zone where slaves lived, and the work-fields became literal places of intense heat, and black smoke like being inside an oven. From the Tribe of Levi a man was born in Goshen who was called the chosen one, and eventually he was also called lawgiver. The name

of this man was Moses. Moses' story is well-known as he adopted into the royal house of Pharaoh through the Pharaoh's sister at the time, and Moses would eventually reject the glory of Egypt to only by forced to flee Egypt. During that time when Moses was dealing with the gathering of the Israelites, and getting them freed from Egypt the Tribe of Levi were his biggest defenders, and supporters while the rest of the tribes found it hard at first to trust Moses.

Page 36:

Eventually some years after those A.D. 60s years the Levi priesthood along with several bands of Israelites tribes sought to make war on the Romans to gain independence. It was the Levi priesthood who started the war because the Romans no longer wanted anything more to do with them. The war ended after a few years at the destruction of the third temple, and the disbanding of the priesthood. The Tribe of Levi lost their homes, and property, and many of them were crucified, and executed in other ways while others were put to slavery. The rest fled into Africa being sheltered there by tribes descended from Solomon's wives.

Page 37:

The Caanites, and the Africans were descended from Ham the third son of Noah. The meaning of the name Ham is 'black' or 'ebony-star' which was to indicate a people born from Ham who would be dark skinned, and considered in a word, 'black.' Judah like his brothers were a brown skinned people sometimes light to dark brown.

Page 43:

When Solomon fell in the way he did most of the Israelites also fell morally as well. When Solomon's son named Rehoboam came to the throne he ordered many of the other wives of Solomon to remove themselves, and their children from Israel. The reason he did this was because he did not want future enemies to deal with. Many of those wives, and their clans left returning to their homelands or going to new lands being offered by Egypt, and Ethiopia as these two empires were selling lands to nobles. Many of Solomon's descendants during that time were arriving in Africa having previous journeys there due to Solomon's expeditions into Africa. In time as Israel became two kingdoms all of Israel was about to undergo really bad years from then on.

Page 45:

Back in Roman times if you were visiting Galilee one of the first things you are told by the Roman citizens is to stay out of Nazareth. Reason being was Nazareth was a dangerous place to live, and was overrun by criminal groups, and gangs. The people of Judah at the time were afflicted with violence, a corrupt religious system, and witchcraft practices. Many of the community groups were extremist groups who wanted to kill the Romans, and restore the throne of Judah. Jesus grew up in Nazareth in the midst of the most heated chaos seen among the people of Israel. The afflictions Jesus saw was a daily reminder of how lost Israel was. Every day in that section of Israel people were murdered, robbed, raped, kidnapped, extorted, vandalized, etc. Every day at least one if not all these crimes would happen. Most of these crimes were Israelites hurting other Israelites as they rarely needed the Romans to do this for them considering how willing there were to do it to themselves.

Page 46:

Israel as you know lost the war against the Romans, and their temple was burned down. Most of the priesthood especially the ones involved in Jesus' crucifixion were burned to death inside the temple when it was burning down all around them. The tribe of Judah at this point fled or were also removed to Africa by the Romans. The Tribe of Judah when they settled in Africa came to Western and Central Africa because those lands were really far away from the Romans. In time they no longer called

themselves the people of Judah. They now became part of African kingdoms and an African tribal system ruled by warlords, and royal-chiefs of those lands. These African Israelites always did know their history, and they even retained many of the Hebrew words, and applied them in their new dialect. But before the invasion of the Dutch company under the British Empire there were Africans who represented various national tribal cultures while maintaining the history of where they came from.

Page 50:

One of the striking things about Native American tribes is shown by the fact that 1,000 words within their national language can also be found in ancient Hebrew. Also 100 of their customs, and traditions can also be found with ancient Hebrew culture. Also the ancient Natives had people who spoke pure Hebrew, and knew the Torah without and European or European Jew teaching it to them. The question became for the scholars, 'How did they know Hebrew words, culture, and religion if they never seen a Hebrew before according to the modern history books?' Could be because history books are written by the victors of wars who change history to suit their propaganda.

Page 52:

Another noted talent of the Issachar tribe was math. The council that held the intercalations of the sun, and moon was often controlled by the Levi priesthood who used many people from the Tribe of Issachar to track the stars, and the movements of the sun, moon, and the planets of the universe, and were able to forecast when they would happen.

Page 57:

The people of Asher at that time fell away from the worship of God as all the tribes did, and began worshipping the gods of the elements, and nature. They became worshipers of ancient witchcraft. Their empire came to an end before the European invasion as they were desolated by a war with the giants. The giants they went to war with tried to take their land when they invaded those lands after a family clan of red-haired giants were scattered from the Middle-East. These giants came to the lands of Asher's people, and sought to take it over; and enslave the people of Asher. For a time they did so but the people of Asher eventually rose up from under their enemies, and fought to gain their lands back. By the time war settled the Europeans were on their way.

The European soldiers being controlled by the Spanish monarchy were the ones who finished off this empire. And then committed genocide on its male population, and their infants & children as well. The women were rounded up, and sent to Spanish forts to be subjected to the breeding programs. As a result from this abusive, and disturbing practice a new generation of Latins (as they called it) were born. Overtime this generation came to call themselves Columbians, Brazillians, etc. having adopted their names from the Spanish builders of these governments.

Page 66:

Since the time the Tribe of Benjamin became loyal to the House of David due to David's kindness towards them after the death of Saul. During the civil conflict the Tribe of Benjamin stayed loyal to Solomon's son because of their love for the House of David. Another reason they stayed loyal to Solomon's son was because Solomon's son was a worshiper of a goddess that the Benjamin tribe became a worshiper of as well. This goddess was eventually called Kali or Shiva.

Page 67:

The year Joseph turned 17 years old is when his life changed forever. That year which was believed to be the year 1895 B.C. Joseph had a vision from God. Joseph in the dream was beholding the entire solar-system of the universe where the earth resides. In that dream Joseph saw the sun, the moon, and

eleven stars meaning eleven planets come before him, and then these gigantic orbs bowed before Joseph.

Page 68:

At the time Egypt was being ruled by the Shepherd Clan who were descendants of Shem, and had been among the first families under Mizraim who first built the government called Egypt after the Flood. At first a Hamitic royal line born from Mizraim were the first rulers of Egypt but a war happened many years before Joseph caused the Shepherd Clan to take over the royal line for that time. When the Hamitic royal family took back Egypt sometime after Joseph died is when the Israelites started to become oppressed, and enslaved by the Egyptians.

Page 69:

The woman that would set-up and frame Joseph was Potiphar's own wife. (In Egypt there was a saying that became popular through television...trust no one.)

Page 73:

The Pharaoh after doing this tells his royal court to bow the knee before the one Pharaoh renamed to, 'Zaphnath-paaneah' which means, 'Savior of the world.' This was know Joseph's new Egyptian name, and title, and the court bows the knee before Joseph. (Talk about a new direction In life.)

Page 73:

When Joseph was given this rank, and title he would not abuse it nor get egotistical over it. He was humble about his position, and truly sought to serve people. Joseph due to his rank had to be given honorary memberships in every occult order of Egypt. This is not to say Joseph was an occult member because clearly he was not. Joseph's honorary titles, and the names given to him regarding these titles were what you call ceremonial awards of Egypt like receiving the Medal of Honor, and the noble peace prize etc. These titles, and names were products of what one receives to become true nobility in Egypt. Every occult priesthood order in Egypt had to acknowledge Joseph, now the knee to Joseph, and in basic terms they had to 'kiss-up' to Joseph in order not to offend the Pharaoh. The City of On in Egypt at the time was considered a city that housed the secrets of electrical, and advanced technology. In fact the word 'on' that is used to turn on lights in our home was a word taken from the Egyptian city called On. That was because On had homes that featured electricity. (Like it or not fans of Edison.) Joseph's palace was built for him in On, and Joseph became part of the royal priesthood family that was directly related to the Pharaoh. The leader of that family was a sun-god priest, and believed to be the nephew of Pharaoh named Potipherah. Potipherah was the high-priest of the City of On, and the holder of the secrets of the gods.

Page 74:

During that time of the first seven years of the prosperous time. Joseph built massive granaries, and stored all kinds of food in it. These granaries were usually located throughout the private government lands of the priesthood, and they were well-protected by Egyptian warriors. These granaries had either an oblong dome appearance, and in some places they were shaped like pyramids. Joseph during that time had enough food stored in those granaries that it was able to feed all the nations of the earth seven times over during the seven years famine that was to come. The granaries Joseph had built were the largest fields of granary domes ever seen or built by a nation in history.

Page 80:

Now that we have examined Joseph let us examine Joseph's two noted sons named Ephraim, and Manasseh. We will start with Ephraim. The various meanings of the name Ephraim is 'twin-land,' and

‘fruitful.’ The overall meaning of the name Ephraim does have a dual meaning that relates to the people themselves, and their prodigy. The overall meaning is seen in the way Ephraim is presented in the ancient Hebrew language where the derivation would be, ‘God caused me to be fruitful in the land of my affliction.’ Ephraim was the second son of Joseph, and his elder brother was Manasseh, and their mutual mother was an Egyptian princess named Asenath. This connection is what brings the bloodlines of Ephraim, and Manasseh within the ancient royal bloodline of the Shepherd Clan that once ruled Egypt along with being part of the Hebrew tribes.

Page 81:

Under the leadership of Joshua Ephraim’s Characteristics are very well noted. They were brilliant, talented, fearless, educated-warrior tribe with a high zeal for God, and religious matters in general.

Page 86:

The Persians would later release what was left of Manasseh to the Middle-East where Manasseh was joined by another outcast people who had taken over the lands when the people of Manasseh were gone. As a result the remnant of Manasseh intermarried with the tribe that was there, and soon a people called the Samaritans came forth. After the Roman-Jewish war many of those Samaritan tribes fled into Eastern Europe. It was believed that they became the outcast groups of what are called, ‘gypsies’ today. The people of Manasseh that were scattered during the Assyrian, and Babylonian invasions ended up with their cousins the people of Ephraim.

Page 86-87:

Ephraim and Manasseh would settle the lands known as the Caribbean today in mainly two islands that were renamed by the Spanish called Puerto Rico (Ephraim), and Cube (Manasseh). The Tainos was a word to mean, ‘Hebrews,’ Christopher Columbus, and the first monarchy invasion sent by the Spanish crown on behalf of the banking families were the ones who shattered their world. The Tainos at this point lost sight of the true faith, and began to worship a wind god, and a fire god along with several other smaller gods. The Tainos foolishly thought Columbus and his men were not a threat in till the Europeans began to poison their water supply, and soon subjected to slavery, and genocide. Many of the surviving males were sent to the silver mines as slaves while they killed the rest. The slaves would be worked to death. Many Tainos after the war committed suicide rather than live as slaves which included whole families. The Europeans focused their genocide efforts on the men, and children of the Tainos. The women of Tainos were forced into breeding programs to produce a generation that will work for European interests. What remained of the Tainos scattered into isolated unmapped islands where they hid from the Spanish for many years in till reservations were eventually secured for them. The generation that was produced were collectively at first called Latins. Later on these Hebrew-European children of Puerto Rico, and Cuba once they came of age were educated on a limited bases by the Catholic Church authorities. They were like a ghost-tribe as they were not accepted by the Spanish, and they were not accepted by the surviving Tainos who were very few in numbers.

Page 88:

Joseph’s character according to God is a reflection of what a faithful person of God should be before their awesome Creator. Joseph was a man with like passions, and sins as all men have. Instead of listening to the evil materials within his soul Joseph instead leans towards the good materials that were composed by his lessons of God. Joseph like all mankind had a balance of good & evil, and strength & weakness along with doubts & fears.

Page 92:

The Danites during that time invaded lands in Northern Europe, and Southern & Eastern Europe as the Danites had battles against the Trojans, the ancient Greeks, and other early Japheth tribes like the Anglos, and Saxons. This part of history is never told that an Israelite tribe invaded Europe many centuries ago like over 4,000 years ago. The real history of the 'bad blood' between Jews, and Europeans first started during the invasion of Dan.

Page 92-93:

The most famous, and even infamous Judge of Israel who came from Dan was Samson the strongest man to ever live as a human being. Samson's story is well-documented as the people of Dan at that point were living too close to comfort with the ways of the Philistines, and they were even subjected to the Philistines.

Page 93:

When Dan officially left Israel this happened after the Danites in Israel bounded their entire tribe to the servitude of Satan.

Page 95:

In this chapter we will examine a book that was once originally part of the Old Testament also called the Torah. This book is called The Testament of the 12 Patriarchs. Like the Book of Enoch the Book of the Testaments of the 12 Patriarchs was removed by the councils that started with the Council of Nice.

Page 96:

Reuben recalls that he was so grateful for the deliverance that he maintained periods of fasting, and would not drink wine or liquor for seven years straight. Reuben recalled that during those seven years he greatly mourned over the sin he committed against his father. During that time Reuben recalled that he could not enjoy food as no good tasting food was ever able to pleasure his senses because of the deep depression he felt over his sin during those years. Reuben's sin was also the first of its kind done in Israel at the time which made that depression even worse.

Page 101:

Simeon would call Satan by another name which was the Prince of Error which was to show Satan's manipulation tactics.

Page 112:

After this, Levi speaks more about the signs of the coming of the Lord, and how awful the priesthood will be during those days. Regarding the Lord Levi states that a star will form as a sign of the Lord's birth. The Lord's ministry was compared by Levi as a person with Power to shine brighter than the sun, and to literally remove the shadows from under the sun. Levi states that all of Heaven will rejoice, and praise the Messiah.

Page 119-120:

Judah gives warning to his people not to allow wine or drugs in general to pervert their minds from the truth because such sensations arouses impulses for sexual desires, and leads the eyes to the path of error. Judah warns his people that sexual promiscuity is like a drug within itself as it is a sin that brings indulgence of the mind. The windpipe was made for song that brings health, and the liver was made to store anger as the gallbladder was made to store bitterness while the spleen can hold laughter. The kidneys can store craftiness, and the loins can store power while the lings, and hips can store strength.

Page 146:

Gad when he became a young man was noted for several feats as a guard of his father's flocks. Gad had encounters with the following creatures that were the lion, the wolf, the leopard, the bear, and even other animals that the translation cannot name because most likely they were of the dragon species.

Page 151:

Asher opens his testimony by stating that God has granted every human being two ways in life. Ethan also discovers, and describes that the Natives Had many Hebrew words in their language that they could not have come up with unless it was already their to start with. The Natives also knew far too many Hebrew Traditions, and they even had prior knowledge of the Messiah Jesus Christ before the Europeans got there. Page 176:

In 2001 a renowned Jewish doctor named Dr. Ariella Oppenheim published an extensive work at the Hebrew University to prove the origins of her Jewish people by the proven science of DNA evidence. She researched that mostly all the European Jews came from a kingdom called Khazar, and they had so much Khazarian bloodlines that hardly any bloodlines existed anymore from an ancient Hebrew tribe. Another European Jewish doctor named Dr. Eran Elhaik led a team of some of the world's finest biologists assembled from McKusick-Nathans Institute of Genetic Medicine, and from John Hopkins University School of Medicine. Their work was to prove the bloodline origins of the European Jews. What they found was the European Jews had no major connections to the bloodlines of Abraham but their bloodlines by the vast majority remained with the Khazar bloodlines. In fact other research even showed that the Palestinians who the Israelites are fighting with have more bloodline connections to Abraham, and the Israelite tribes than the European Jews.

Page 176:

Rabbis are taught that their language called Yiddish is a form of ancient Turkish Arabic, and it has nothing to do with Ancient Hebrew. Also the reason why this culture is Jewish is because the Jewish part did not signify a people but a religion the Khazars wanted to embrace. In fact a famous Jewish teacher from Hebrew University named Gershow Scholem who was actually a professor of Kabbalah openly told his students throughout his term there that the Kabbalah was used for calling on spirits to disturb the natural order God had for people, and the environment. The most famous symbol seen on the national flag of Israel. Many Israeli teachers will foolishly teach you that the star is the Star of David that was instituted by Solomon. That entire teaching is false. The six-sided hexagram was around centuries before the birth of David, and Solomon. It was first recorded among the ruins, and records of Summer, and Egypt. Within the Summer record the creator of the star was Cain who received the symbol from Satan. The star represented a demonic rebirth among mankind. 666 is what the star forms from the edges of its side to represent that this spiritual transformation is being provided by the Church of Satan meaning from those who rule the world. The Zionist adopted the symbol of forces of Satan, and called it the Star of David as a way to make it sound righteous when it is not based on anything righteous to the Bible.

Page 195-196:

Most of the People of Dan settled in an area that was upon, and near the Caspian Sea. That is the same area that houses cultures like the Hungarians, Russians, and the Bulgarians, etc. During the days of the Roman Empire is when the people of that area started to call themselves Khazarians. Their religion was the worship of the gods, and their main god was the sun-god in the form of Lucifer. During the days of the Byzantine emperors the Khazar government had to yearly fight off invading Arab, and Persian armies from the Middle-East. This is where their long history of hatred for the Arabs came from. The Byzantine emperors did not trust the Khazars nor their warlike leaders as they often found them to be subversive to their rule. The relationship between the Byzantine government, and the

Khazars was that the Khazars worked for their military, and acted as their 'special forces' in those regions. The Khazars had invaded Armenia, and Crimea during that time to subdue their governments to the eastern Roman power. In time the Byzantine government was having many internal problems as a power struggle unfolded between the Khazar nobles, and the established Byzantine nobles. The Byzantine nobles began to lose their power, and became fearful of the Khazars. As a result the Khazars gained a behind the scenes control over the Byzantine government, and forced that government to even pay them tribute in the form of taxes. (Aaron Russo was right by the way.) When Khazars gained this behind the scenes control they formed a shadow government within the Byzantine system. They formulated policies of expansion that will come by way of war, and sabotage. The Russian Empire was believed to have been established by the Khazars along with several other eastern European nations as they engaged in various agendas of expansion that were planned out by the Khazars. However groups like the Mongolians, Arabs, and Persians often ruined their plans causing a bitter rivalry between the ruling families of the earth.

Page 196:

In the mid-700 A.D. period the Khazars started to have problems with the Catholic Church that supposedly represented Christianity in the world. (By the way the popes were horrible at their job.) The Khazars also started to have problems with the Muslim nations that arose during the wars, and movements started by Mohammed in the 600 A.D. period. The monarchy governments wanted to dismantle the Khazar shadow government by destroying their open central government they had upon the Caspian region. These problems came to an extreme head at the time Khazar was being ruled by King Bulan. Bulan was being set-up by the Muslim powers, and was being betrayed or more-like paid back for his deeds by the Catholic Church council. Bulan at the time was worshiping the Talmud-Kabbalah doctrine which was called 'Judaism' in Europe. The Talmud was also being observed by many eastern governments among their noble rulers who had nations that Bulan could make an alliance with to strengthen his position against the Muslims, and the Catholics. In 740 A.D. Bulan would declare a national governmental religion for his kingdom. The religion he declared to be the only legal religion in his realm was Judaism in the form of the Talmud. Those who observed the traditional Old Testament commandments, and rejected the Talmud were shunned in those lands as being perceived as 'weak-Jews' according to the Talmud believers of those times. Those types of 'Jews' as they were called were oppressed along with non-Catholic Christians. In fact the people that were often targeted in Europe for great oppressions were people who were not favorable to corrupt governments. (Always remember that.)

Page 197:

The religious beliefs that was openly declared by Bulan was in fact already within his royal house before he was born, and the Talmud believers often kept their world confined, and sheltered from the outside world. In time the Khazars could not maintain their open central government as too many invading forces overwhelmed it. As a result the Khazar nobility went into the nobilities of various monarchy families in the east, and west of the monarchy families of Europe. In time they started to become the power behind the thrones as they gained control of their financial wealth, and resources by starting up privately owned banks in those nations. The Khazar people unlike the nobles were scattered about several European countries after losing their own country. They were hated upon everywhere they went. They were aggressively kicked out of most countries they came to. In fact about 109 governments of those times kicked the Khazarian Jews out from their countries for various reasons that involved mostly sabotage, and terrorism. The European Jews would say they were being unfairly treated, and hated upon for being 'Jewish.' however in some cases that was true; but in other cases that was not true. Many times the Khazars were indeed guilty of sabotaging governments, and causing terrorist acts in those governments whereby they were kicked out for such foolishness. To be kicked out

an entire nation is a very strong, and unlikely action a government would take considering the manpower, and the resources the feudal government would need in order to kick out a whole culture of people from their lands. For them to go through that much trouble showed there was something more than just racial discrimination going on. Discrimination was an everyday occurrence in Europe that usually did not involve an entire people from being kicked out of a country over it. When an excuse like that is used for such an action that excuse is truly nothing but an excuse.
